BODY-WORN CAMERA POLICY AND IMPLEMENTATION PROGRAM, FISCAL YEAR 2019

Body-worn cameras (BWCs) are a proven law enforcement tool that has improved officer and public safety, reduced crime, enhanced evidentiary value, and helped to build trust between police and the citizens they serve. The Department of Justice provides numerous resources to assist state, local, and tribal law enforcement agencies in developing and enhancing their BWC programs. Chief among them are the Bureau of Justice Assistance's (BJA's) competitive grant program, its BWC Toolkit, and its training and technical assistance (TTA).

Body-Worn Camera Policy and Implementation Program (BWC-PIP)

In fulfillment of the Administration's commitment to expand funding, training, and evidentiary tools for law enforcement and other criminal justice agencies, BJA has provided more than \$73 million in Body-Worn Camera Policy and Implementation Program (BWC-PIP) awards during the past 5 years to respond to the immediate needs of state, local, and tribal law enforcement organizations. Throughout BWC-PIP's history, BJA has provided awards to agencies in nearly every state and to several agencies operating in tribal areas and territories (see program award map on reverse page).

In Fiscal Year (FY) 2019, BWC-PIP expanded significantly: Nearly \$20.5 million in BJA awards were provided to 82 grantees (see list of grantees on reverse page). A number of BWC-PIP awards are administered as multiagency partnerships or through regional and state consortia. For example, in FY 2019, the Pennsylvania Commission on Crime and Delinquency received a BWC-PIP award to support BWC implementation in 29 law enforcement agencies throughout the state.



Body-Worn Camera Toolkit and TTA

The BJA Body-Worn Camera Toolkit is an online resource for stakeholders that includes lessons learned for implementation, model policies and procedures, and research materials. To assist grantees, the toolkit consolidates and translates research, promising practices, templates, and tools that have been developed by subject matter experts. In addition, all agencies funded through the BWC-PIP program have access to TTA to help them develop their policies and plans for implementation. BJA's TTA provider, CNA's Institute for Public Research, provides resources and assistance through its BWC-TTA website.
